Food Sovereignty Bill

- On June 16th, 2017, Governor LePage signed a new food sovereignty bill into law. LD 725, An Act to Recognize Local Control Regarding Food Systems. The law will take effect 90 days after the 128th Legislature adjourns and will impact towns that have already declared food sovereignty. In those towns, local ordinances will supersede state food safety regulations.
- Maine Food Sovereignty Act

Local Control

- Local food system. "Local food system" means a community food system within a municipality that integrates food production, processing, consumption, direct producerto-consumer exchanges and other traditional foodways to enhance the environmental, economic, social and nutritional health and well-being of the municipality and its residents.
- A municipal government may regulate by ordinance local food systems, and the State shall recognize such ordinances. An ordinance adopted by a municipality pursuant to this section must apply only to food or food products that are grown, produced or processed by individuals within that municipality who sell directly to consumers.



Maine Leads the Nation

 "Maine becomes the first US state to recognize the Right to Food in a Constitutional amendment" All individuals have a natural, inherent and unalienable right to save and exchange seeds and the right to grow, raise, harvest, produce and consume the food of their own choosing for their own nourishment, sustenance, bodily health and well-being...



How to implement Food Sovereignty Ordinance

- Reach out to other community members you know to see if there is interest, and need for you in your community.
- Check to see if your community has an FSO in place.
- As applicable, reach out to your city/town counselors or select people to gain their support, and/or educate them on why you or your group feel an FSO is a valuable addition to your community.
- Reach out to the municipal staff in your community to ask about the process for implementing, or changing ordinances in your community

Compliance with food safety regulations

 Any food or food products grown, produced or processed in the municipality intended for wholesale or retail distribution outside of the State of Maine, produced or processed in compliance with all applicable state and federal laws, rules and regulations



Summary

Allowed

- Home grown and produced
- Sold directly to consumer
- Produce
- Prepared goods
- Seafood
- Retailing outside of local municipality

Licensing Required

- Wholesale production
- Meat
- Poultry
- No "double dipping"
